SECTION 4: First aid measures

Description of first aid measures

General information	Get medical attention immediately. Show this Safety Data Sheet to the medical personnel. Chemical burns must be treated by a physician.
Inhalation	Remove affected person from source of contamination. Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Maintain an open airway. Place unconscious person on their side in the recovery position and ensure breathing can take place.

Methods for cleaning up

Small Spillages: If the product is soluble in water, dilute the spillage with water and mop it up. Provide adequate ventilation. Personal, workplace environment or biological monitoring may be required to determine the effectiveness of the ventilation or other control measures and/or the necessity to use respiratory protective equipment.
