SECTION 4: First aid measures

Description of first aid measures

General information

Get medical attention immediately. Show this Safety Data Sheet to the medical personnel.

Inhalation

Remove affected person from source of contamination. Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Maintain an open airway. Appropriate engineering controls

Provide adequate ventilation. Personal, workplace environment or biological monitoring may be required to determine the effectiveness of the ventilation or other control measures and/or the necessity to use respiratory protective equipment. Use process enclosures, local exhaust ventilation or other engineering controls as the primary means to minimise worker exposure. Personal protective equipment should only be used if worker exposure cannot be controlled adequately by the engineering control measures. Ensure control measures are regularly inspected and maintained. Ensure operatives are trained to minimise exposure.

Eye/face protection

Considering the data specified by the glove manufacturer, check during use that the gloves are retaining their protective properties and change them as soon as any deterioration is detected. When used with mixtures, the protection time of gloves cannot be accurately estimated. Gloves made from the following material may provide suitable chemical protection: Nitrile rubber. Thickness: >0.2mm The selected gloves should have a breakthrough time of at least 0.5 hours. Glove thickness is not necessarily a good measure of glove resistance as the permeation rate will depend on the exact glove composition. Repeated exposure to chemicals will degrade the ability of the glove to provide resistance to chemicals. Specific work environments and material handling practices may vary, therefore safety procedures should be developed for each intended application.
