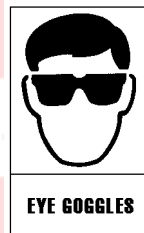
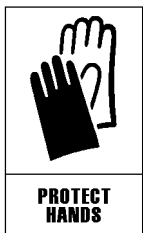

**7 HANDLING AND STORAGE****Handling:**

Keep away from heat, sparks, open flame and other sources of ignition. Keep out of reach of children. Avoid contact with skin and eyes and do not inhale spray mist.
