### Description of first aid measures

<b>General information</b>	Get medical attention if any discomfort continues. Show this Safety Data Sheet to the medical personnel.

### SECTION 5: Firefighting measures

#### Extinguishing media

#### Advice for firefighters

**Protective actions during firefighting** Avoid breathing fire gases or vapours. Evacuate area. If a leak or spill has not ignited, use water spray to disperse vapours and protect men stopping the leak.

#### Personal precautions, protective equipment and emergency procedures

**Personal precautions** No action shall be taken without appropriate training or involving any personal risk. Keep unnecessary and unprotected personnel away from the spillage. #### Environmental precautions

#### Methods and material for containment and cleaning up

**Methods for cleaning up** Wear protective clothing as described in Section 8 of this safety data sheet. Clear up spills immediately and dispose of waste safely. Reuse or recycle products wherever possible. Approach the spillage from upwind. Small Spillages: If the product is soluble in water, dilute the spillage with water and mop it up. Alternatively, or if it is not water-soluble, absorb the spillage with an inert, dry material and place it in a suitable waste disposal container. Large Spillages: If leakage cannot be stopped, evacuate area. Flush spilled material into an effluent treatment plant, or proceed as follows. Contain and absorb spillage with sand, earth or other non-combustible material. Place waste in labelled, sealed containers. Clean contaminated objects and areas thoroughly, observing environmental regulations. Flush contaminated area with plenty of water. Wash thoroughly after dealing with a spillage.
