## SECTION 4: First aid measures

### Description of first aid measures

**General information** Get medical attention if any discomfort continues. Show this Safety Data Sheet to the medical personnel.

**Inhalation** Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Maintain an open airway. Loosen tight clothing such as collar, tie or belt.
