### SECTION 4: First aid measures

#### Description of first aid measures

<b>General information</b>	Get medical attention immediately. Show this Safety Data Sheet to the medical personnel.
<b>Inhalation</b>	Remove affected person from source of contamination. Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Maintain an open airway. Alternatively, or if it is not water-soluble, absorb the spillage with an inert, dry material and place it in a suitable waste disposal container. #### Appropriate engineering controls

Provide adequate ventilation. In view of the potential degree of exposure, there should be no cancer risk to humans.
