SECTION 4: First aid measures

Description of first aid measures

Usage precautions

Avoid exposing aerosol containers to high temperatures or direct sunlight. The product is flammable. Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Do not spray on an open flame or other ignition source. Pressurized container: Do not pierce or burn, even after use.
