SECTION 4: First aid measures

Description of first aid measures

The breakthrough time for any glove material may be different for different glove manufacturers. To protect hands from chemicals, gloves should comply with Australia/New Zealand Standard AS/NZS 2161. Considering the data specified by the glove manufacturer, check during use that the gloves are retaining their protective properties and change them as soon as any deterioration is detected. Frequent changes are recommended. The choice of protective gloves depends upon the chemicals being handled, and the conditions of work and use.
