#### SECTION 4: First aid measures

#### Description of first aid measures

#### General information

CAUTION! First aid personnel must be aware of own risk during rescue! First aid personnel should wear appropriate protective equipment during any rescue. Get medical attention immediately. Effects may be delayed. Keep affected person under observation. Show this Safety Data Sheet to the medical personnel. Chemical burns must be treated by a physician.

#### Inhalation

Remove affected person from source of contamination. Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Maintain an open airway. Loosen tight clothing such as collar, tie or belt. When breathing is difficult, properly trained personnel may assist affected person by administering oxygen. Place unconscious person on their side in the recovery position and ensure breathing can take place. Symptoms of lung oedema (shortness of breath) may develop up to 24 hours after exposure. Get medical attention immediately.

# Ingestion

Rinse mouth thoroughly with water. Remove any dentures. Give a few small glasses of water or milk to drink. Give milk instead of water if readily available. Stop if the affected person feels sick as vomiting may be dangerous. Do not induce vomiting unless under the direction of medical personnel. If vomiting occurs, the head should be kept low so that vomit does not enter the lungs. Never give anything by mouth to an unconscious person. Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Place unconscious person on their side in the recovery position and ensure breathing can take place. Maintain an open airway. Loosen tight clothing such as collar, tie or belt. Get medical attention immediately.

# Skin Contact

It is important to remove the substance from the skin immediately. Take off immediately all contaminated clothing. Care should be taken to avoid contact with contaminants when removing contaminated clothing. First aid personnel should wear appropriate protective equipment during any rescue. Rinse immediately with plenty of water. Continue to rinse for at least 10 minutes. Apply Calcium Gluconate Gel over the affected areas. Get medical attention immediately. Effects may be delayed. Chemical burns must be treated by a physician. Show this Safety Data Sheet to the medical personnel. Wash contaminated clothing before reuse.

# Eye contact

Get medical attention immediately. Rinse immediately with plenty of water. Remove any contact lenses and open eyelids wide apart. Continue to rinse for at least 10 minutes. Consult a physician for specific advice. Effects may be delayed. Medical aid should instil several drops of sterile calcium gluconate solution. Show this Safety Data Sheet to the medical personnel.

# Protection of first aiders

# Personal precautions

# Appropriate engineering controls

Provide adequate ventilation. Personal, workplace environment or biological monitoring may be required to determine the effectiveness of the ventilation or other control measures and/or the necessity to use respiratory protective equipment. Use process enclosures, local exhaust ventilation or other engineering controls as the primary means to minimise worker exposure. Personal protective equipment should only be used if worker exposure cannot be controlled adequately by the engineering control measures. Ensure control measures are regularly inspected and maintained. Ensure operatives are trained to minimise exposure.

# Eye/face protection
