Description of first aid measures		
General information	CAUTION! First aid personnel must be aware of own risk during rescue! First aid personnel should wear appropriate protective equipment during any rescue. Inhalation	Remove affected person from source of contamination. Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Maintain an open airway. Loosen tight clothing such as collar, tie or belt. When breathing is difficult, properly trained personnel may assist affected person by administering oxygen. Place unconscious person on their side in the recovery position and ensure breathing can take place. Symptoms of lung oedema (shortness of breath) may develop up to 24 hours after exposure. Get medical attention immediately.	
Ingestion	Rinse mouth thoroughly with water. Remove any dentures. Give a few small glasses of water or milk to drink. Give milk instead of water if readily available.
